- Ask for an attorney
- Make a phone call if you are arrested

- Do *not* carry false documents.
- Carry an information card with you. A copy of the "Know Your Rights" card can be found at [www.nilc.org/ce/nilc/rightscard\_2007-03-15.pdf].
- Find the name and telephone number of an immigration lawyer you trust and always carry this information.
- Prepare a document that authorizes another adult to care for your children, if minors.
- Do not sign any documents before consulting with a lawyer.
