



POSITION ANNOUNCEMENT

Domestic Violence Support Group Facilitator

Bradley Angle is a dynamic social service organization offering safe shelter and supportive services to survivors of domestic violence and their children since 1975. We offer an array of holistic programs and services focused on economic empowerment, housing assistance, LGBTQ programming, Healing Roots (a culturally-specific program for African American survivors), group support, emergency shelter and youth and family supports. At Bradley Angle, we aim to have our staff reflect the populations we serve and encourage applicants from those communities to apply. We are currently hiring group facilitators for our structured domestic violence support group. The group facilitators will co-facilitate discussions relating to domestic violence among group participants.

STATUS: This is a non-benefited, exempt part-time position.
SALARY: \$15/hr.
HOURS: Approx. 3-5 hours a week (2 hours for group facilitation, 1-3 hours for planning/preparing for group and writing progress notes). Groups are in the evenings.
SUPERVISOR: Community Based Services Manager

DUTIES/RESPONSIBILITIES:

1. Work with participants, co-workers, supervisor and all other relevant stakeholders in a manner that is consistent with, and promotes, Bradley Angle Ethical Commitments and Bradley Angle Organizational Values.
2. Comply with Bradley Angle policies and procedures, including maintaining strict confidentiality protocols.
3. Prepare for, set-up and facilitate group sessions using existing curriculum.
4. Facilitate an empowering space for survivors by fostering group cohesion and ownership among participants.
5. Shop using gift cards and prepare food for groups in the on-site kitchen.
6. Clean up after each group.
7. Complete intake paperwork with new participants.
8. Keep progress notes for participants and submit group statistics monthly.
9. Attend required quarterly supervision and requested agency meetings.

QUALIFICATIONS:

1. Ability to relate to survivors of all ages from diverse backgrounds.
2. Commitment to working with survivors of domestic violence and knowledge of domestic violence and its effects on society. Demonstrated strength in communicating the dynamics of intimate partner violence.
3. Commitment to social change including working to end domestic and sexual violence and all forms of oppression: racism, heterosexism, trans oppression, ableism, sexism, classism, etc.
4. Understanding the linkages between domestic and sexual violence and other forms of oppression.

5. Skilled in crisis intervention.
6. At least one year of experience in group facilitation, peer support, establishing professional/personal boundaries and relationship building.
7. At least one year of social service experience specific to domestic violence.
8. It is preferred that candidates have completed the 40-hour Basic Advocacy Training through an Oregon Domestic Violence/Sexual Assault Agency or have the ability to complete it on their own before start date.
9. Bachelor's degree in social work or therapeutic program is beneficial but not required.
10. Working knowledge of computers.
11. Reading and writing skills which include ability to access and utilize a variety of resource materials in a timely manner, and maintain accurate records.
